

Risk Assessment for The Bossard String Quartet

1. Hazard Identification:

1.1. Physical Hazards:

- a. Slips, trips, and falls due to uneven flooring or obstacles.
- b. Musicians may accidentally collide with each other, causing injuries.
- c. Strains or sprains from lifting and carrying heavy musical instruments.

1.2. Environmental Hazards:

- a. Extreme weather conditions (e.g., rain, heat) affecting outdoor performances.
- b. Insufficient lighting in the performance area.

1.3. Health Hazards:

- a. Allergic reactions to dust, pollen, or other allergens present at the venue.
- b. Musicians may experience physical discomfort or pain due to prolonged playing.

1.4. Security Hazards:

a. Theft or damage to musical instruments when left unattended.

2. Risk Analysis:

2.1. Likelihood of Occurrence (LO):

The likelihood of each hazard occurring is assessed on a scale of 1 to 5, with 1 being unlikely and 5 being highly likely.

2.2. Severity of Consequences (SC):

The potential consequences of each hazard occurring are assessed on a scale of 1 to 5, with 1 being negligible and 5 being severe.

2.3. Risk Level (RL):

The risk level is determined by multiplying the likelihood of occurrence (LO) by the severity of consequences (SC).

4. Risk Control Measures:

4.1. Slips, trips, and falls:

4.6. Allergic reactions:

- Inform quartet members of potential allergens at the venue.
- Encourage musicians with known allergies to take necessary precautions (e.g., medication).

4.7. Physical discomfort:

- Provide comfortable seating arrangements for musicians during breaks.
- Encourage musicians to practice proper posture and ergonomics.

4.8. Theft or damage:

Assign a designated area for musicians to store their instruments securely when not in use.

Implement measures such as surveillance or security personnel to deter theft.

Ensure that the storage area is protected from environmental hazards (e.g., temperature fluctuations, humidity) that could damage the instruments.

Establish clear guidelines for handling and transporting the instruments to minimize the risk of accidental damage.
